THE AUDIT COMMITTEE IS CHARGED WITH OVERSIGHT FOR THE AUDIT, REVIEW OF THE IRS FORM 990, AND PRESENTATION OF THE AUDIT REPORT AND FORM 990 TO THE BOARD OF DIRECTORS FOR FINAL REVIEW AND APPROVAL. THERE HAVE BEEN NO CHANGES TO THE AUDIT COMMITTEE'S DUTIES AND RESPONSIBILITIES DURING THE CURRENT YEAR.
